**Loon Report** 

Sat., the 17th of July, the official Audubon Loon count took place from 7:00 AM to 7:30 AM. Bob and I went with Mary and Ernie Shaw. Our first loop around the lake began with a view of the loon's nesting site....which is

still intact. We continued around the lake and at 7:20 saw a raft of 9 loons near the So.East shore area. We saw no baby chicks this year. On June 28th, 2 baby chicks were spotted one day, gone the next and never sighted again. The 9 loons we countered appeared to have 4 or 5 young adults among them....a young adult is usually considered a baby loon from the previous year's hatching. Several people living on the lake have noticed eagles landing in the nesting area and one was seen sitting on the loon nest... this was after the nesting season. We can't help but feel the chicks were pray for them also.

Mary Shaw is taking part in the Audubon Productivity Loon Count which began in June and will continue until Sept. 30th. This count is to cover the many phases of a loon's life span; what positive effects exist for a loon as well as the negative ones. This group will monitor loons on a daily and weekly basis.

# **Proposed Bylaws Change**

We have discussed at recent meetings the problems posed by our current membership arrangement i.e., one property, one vote. This policy seems unfair to those people who don't necessarily agree with their spouse on various voting issues. The proposed change: Each property shall be entitled to one vote if they have a single membership and a maximum of two votes if they have a Family Membership regardless of the number of owners of that property. Likewise, each member shall be entitled to only one vote regardless of the number of properties owned or jointly owned by them. Give this issue some thought and come prepared to discuss it at the annual meeting. ARTICLE VIII DUES, currently reads: Dues shall be \$20.00 per year unless changed by vote of the membership at the annual meeting. The terms of members shall be from the start of one annual meeting to just prior to the start of the next annual meeting.

Proposed New **ARTICLE VIII DUES**: change: Dues shall be \$25.00 per year for a Single Membership and \$40.00 for a Family Membership unless changed by vote of the membership at the annual meeting. Single Memberships shall be entitled to one vote. Family Memberships shall be entitled to two votes. The terms of membership shall be from the start of one annual meeting to just prior to the start of the next annual meeting.
